Terms and Conditions of Sale.

1. That upon the fall of the hammer the highest bidder shall be declared the purchaser, and in the event of any dispute arising the lot or lots shall be put up again and no one shall retract his or her bidding.
2. No one shall bid less than \$5.00 at a time.
3. The vendors reserve to themselves the right of passing in such lots as may not reach the upset price they have placed upon them.
4. The terms of payment shall be One-fourth Cash. Balance in equal instalments at one, two and three years, bearing interest at the rate of 6 per cent. per annum. Ten per cent. of the whole amount of purchase money to be paid on the fall of the hammer, which shall be applied on the first instalment, balance of first instalment to be paid within 5 days of date of sale.
5. The Title of the Property is indefeasible.
6. If the purchaser shall fail to comply with any of these conditions all monies paid by him on account shall be forfeited to the Vendors who may, with or without notice, resell the property by auction or otherwise on such terms and conditions as they may think fit, and shall not be liable to him further or otherwise.
7. Articles of Agreement will be furnished free of charge, Crown Grant at a fee of \$10.00 and Deeds of Conveyance at a charge of \$5.00.

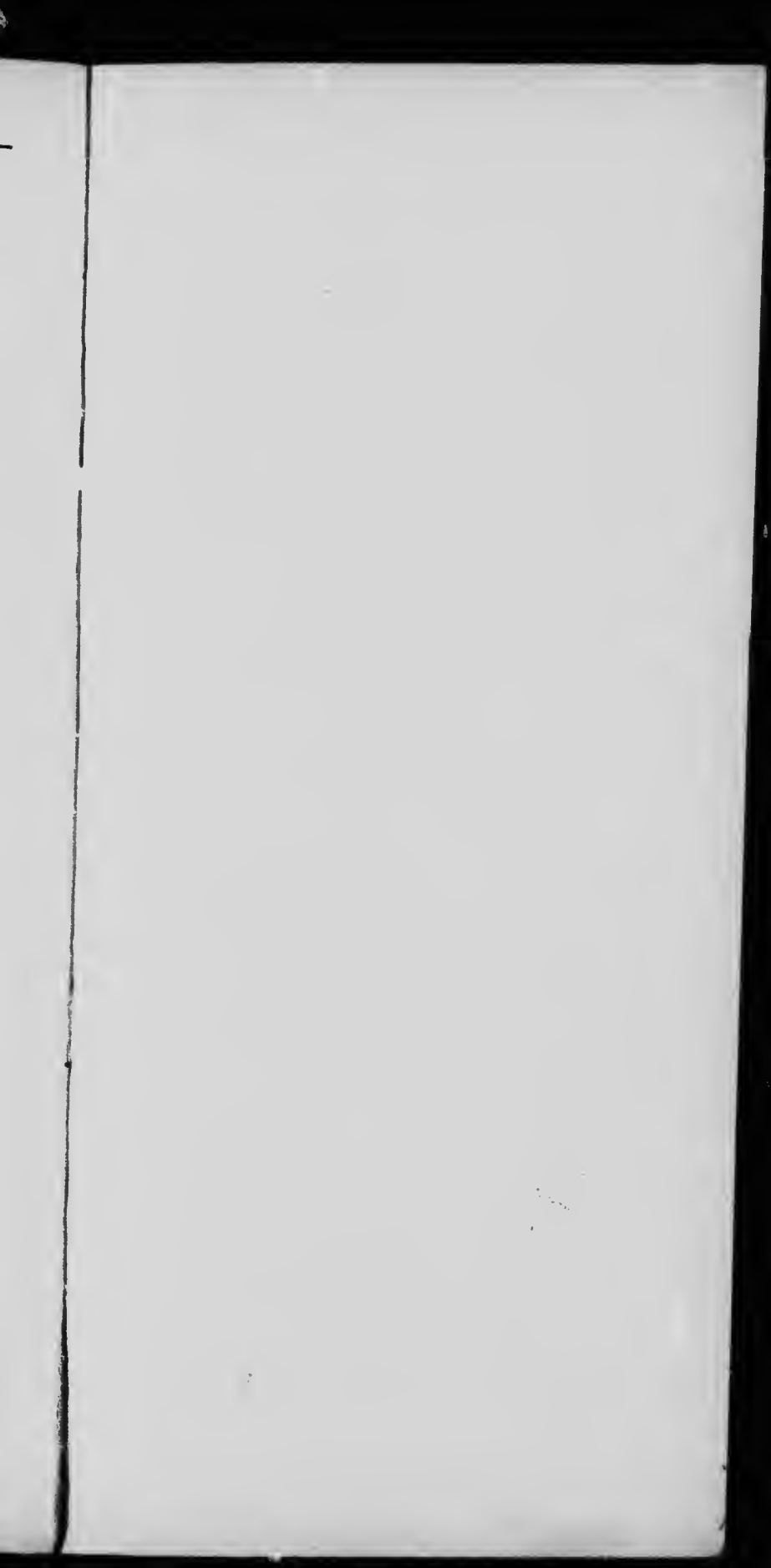
